Dean Vitas,

The Crisis Response Systems and Exercises section in the Operations Division provides direction and coordination on the elaboration of the Alliance's crisis management and response system policy, organisation and procedures, including for ART.5. It also provides direction and coordination on high level exercising and on Alliance lessons learned. The section provides coordinated policy advice and recommendations to the Council Operations and Exercise Committee (COEC), and associated bodies in support of the maintenance, revision, implementation and North Atlantic Council-level exercising of the NATO Crisis Response System, and of the maintenance and review of the NATO policy for lessons learned.

You will highly appreciate that since 2014, with the change of posture of the Alliance, and the enhanced focus on Collective Defence, the workload of this section has substantially increased. Deliverables such as the revision of the NATO Crisis Response System Manual and the conduct of challenging and ambitious political military high-level exercises, or scenario-based discussions have always been commended by Allies but are now going to be complemented by short notice exercises. Interaction with Finland, Sweden and EU have also increased. However, the capability and capacity of this section have remained unchanged.

In the light of the above, I would like to invite Lithuania to consider offering as a National Contribution, a strong candidate to reinforce the Crisis Response Systems and Exercises Section within the Operations Division of the International Staff. To facilitate your decision-making, an indicative job description is provided at enclosure. PO(2015)0202 on the "NATO-wide Policy on Voluntary National Contributions from NATO Member States", will apply for this post.

VOLUNTARY NATION CONTRIBUTION INDICATIVE POST DESCRIPTION

1. SUMMARY

The Operations Division of the International Staff provides comprehensive advice and support to the Secretary General, the North Atlantic Council, Allies and partners to facilitate the decision-making process relating to the entire spectrum of crisis management, including Art 5 and non-Art 5. This advice and support covers strategic political, civil and military aspects of current and potential operations, missions, assistance and exercises. The Division fulfills the following key functions: Manage the political decision-making process with regard to preparing for planning, executing, and transitioning NATO operations, missions and assistance; and serve as the focal point for disaster response and crisis management policy and implementation within NATO.

Under the authority of Director for Operations, the Crisis Response Systems and Exercises (CRSE) Section manages the political decision-making process related to planning and is the focal point in NATO HQ for the full spectrum of Crisis Management in NATO, including collective defence. The CRSE Section provides direction and coordination on the elaboration of the Alliance's crisis management and response system policy, organisation and procedures, including on high level exercising and on lessons learned.

The incumbent will assist the Head, CRSE Section and, as required, the other senior Staff officers in the staffing and preparation of advice and recommendations to the Council Operations and Exercise Committee (COEC) and associated bodies. These include the support of the maintenance, revision and operation of the NATO Crisis Response System (NCRS), the adaptation and improvement of the operating procedures for crisis management and collective defence in the Alliance, the interaction with selected partners, the crisis management procedures for NATO Headquarters (HQ), short notice exercises and NATO-EU interaction. They also include the lessons identified, as well as the scheduling, planning and conduct of high-level crisis management exercises at the political/military strategic level, including in Capitals.

2. QUALIFICATIONS AND EXPERIENCE/BACKGROUND

CRSE is looking for a A grade civilian with significant experience in the crisis management field; has a good understanding of civil-military crisis management in the national and/or international context of political or operational affairs, demonstrates good political judgment, and has a broad knowledge and understanding of current international events and the security environment. He/She has strong English, drafting and communication skills, and can be available as soon as possible and at least for one year.

Essential:

- Must have demonstrated self-initiative, resilience, flexibility and be a professional as well as collaborative team member;
- Strong analytical, drafting and communication skills;
- Familiarity with NATO's Crisis Response System.
- Familiarity with COEC issues.
- Familiarity with the work at cabinet level/ and or in a Delegation.

- NATO SECRET clearance.

4. VOLUNTARY NATIONAL CONTRIBUTION CONDITIONS

- Conditions for a nation sending an employee as a Voluntary National Contribution to the NATO International Staff are as outlined in PO(2015)0202, NATO-wide Policy on Voluntary National Contributions from NATO Member States.
- In short:
 - the sending nation is responsible for the Voluntary National Contribution's contractual employment, salary and possibly per diem or other allowances, and vacation entitlement,
 - the sending nation or the Voluntary National Contribution him-/herself are responsible for housing, insurances, local transport, etc.,
 - the International Staff is responsible for provision of computers, mobile phones, workspace and other requirements for the daily fulfilling of the job, and for transports and accommodation when/if the Voluntary National Contribution would travel on a NATO related mission.
